Terms and Conditions of Group Specials with \$25.00 Deposit Crystal & Clear Travel - Carnival Cruise Line

- \$25.00 non-refundable deposit locks in price and category for DOUBLE occupancy cabin booked at Group Special rates. Cabins that accommodate 3 and 4 persons may also be reserved with the same deposit per person; however, 3 or 4 person cabins are limited in their availability and we recommend making full Carnival deposit when booking these cabins. (Note-special cabins, suites, and certain balcony cabins may require the full Carnival deposit in order to reserve the space if not in travel agents allotment).
- Reservations are held with the \$25.00 deposit locking in price and category for a DOUBLE occupancy cabin, allowing payments towards the total cost of the trip. Your cabin can not be berthed until you have reached Carnival's minimum deposit amount, which is based on the following criteria:
 - 3 & 4 night cruise, based for berthing your cabin, is \$150.00 per person
 - 5 night cruise, base for berthing your cabin, is \$200.00 per person
 - 6, 7 & 8 night cruise, base deposit for berthing your cabin, is \$250.00 per person
 - 9 & 10 night cruise, base deposit for berthing your cabin, is \$400.00 per person
 - 12 night cruise, base deposit for berthing your cabin, is \$500.00 per person
 - Alaska Cruises start at \$300.00 per person for base deposit to berth a cabin
- If, when your reach the full deposit for a 3 or 4 person cabin, we cannot find cabin space, you may have to decide whether to cancel your travel or book an additional cabin. Booking an additional cabin may result in a higher price. Should you decide to cancel the \$25.00 deposit per person is non-refundable.

Interest Free Monthly Payment

- Crystal & Clear Travel offers the interest free payment options. When you make your reservations a verbal agreement is made between guest and travel agent for monthly payments to occur. [This is not something from Carnival Cruise Line.](#)
- The guest will receive a statement by email or they will be part of our travel group (Gold Country Cruise) and receive a statement online to view. [Again this is not from Carnival Cruise Line.](#)
- With a the verbal agreement payments are due on the due date agree upon by 8am each month until paid in full. Should you miss two payments in a row your forfeit your rights to your reservation thus losing all your monies. It is strongly recommended to purchase the cruise insurance.

- You may choose to make additional payments, pay it in full earlier, and change the address or credit card at any time.
- Once payments have started and you have not included the insurance and have to cancel your monies are non-refundable. If insurance was purchased then any monies on your reservation other than the deposit and insurance would be released back to you. This process may take up to 7-10 business days to be returned to you in the form in which you paid for it from cruise line.

Travel Documentation for Cruising

- Proof of Citizenship is required of all guests. Crystal & Clear Travel and Carnival Cruise Line are not responsible for guests not traveling with the documents necessary for travel. Notice is given at time of reservations and at certain points before your cruise notice is sent again regarding Proof of Citizenship.
- Some cruises will require a passport and others will only require certified copy of birth certificate and marriage license of those women with a changed name. It is however, highly recommended to travel with a passport.
- Traveling with small children without other parent or bringing along a child from another family the following is required: When traveling with a minor and both parents/legal guardian are not cruising you must bring a notarized letter from the absent parent/legal guardian authorizing the minor to travel with you. This will expedite processing by the Department of Homeland Security.
- Any guest without proper documents will not be allowed to board the vessel and no refund of the cruise fare will be issued. Carnival Cruise Line and Crystal & Clear Travel assumes no responsibility for advising guests of immigration requirements.

Please Note:

Carnival reserves the right to re-instate the fuel supplement for all guests at up to \$9 per person per day should the price of light sweet crude oil according to the NYMEX (New York Mercantile Exchange Index) increase above \$70 per barrel.

In addition you will not find these conditions on Carnival's website some of the rules are imposed on all travel agents from Carnival and some of the rules are Crystal & Clear Travels.
